





## Background

- Legislative change requirement for a BSc degree in social work or equivalent to work in social services child and youth care.
- Supplementary education only for foreign degrees
- Received funding to develop a model for validation and specific validation criteria for the BSc degree in social work.

# Our model – the example of Social Work

- Qualitative targets national level
- Learning outcomes
- Meetings with directors of studies and study councelors in Stockholm,
   Göteborg, Umeå, Malmö och Lund
- Interviews with 15 professors about the core of social work

## Qualitative targets (national level) Knowledge and understanding

For the social work degree, the student must

- demonstrate such knowledge and ability as is required for independent social work at individual, group and community level.
- demonstrate knowledge of the area's scientific basis and knowledge of current research and development work,
- demonstrate knowledge of and understanding of the interplay between individuals and groups social situation, living conditions, physical and mental health and functional ability in relation to societal and other underlying factors,
- demonstrate knowledge of social work management,
- demonstrate knowledge of and understanding of children's needs and such social and family conditions that affect the living conditions of women and men, and
- show knowledge about men's violence against women and violence in close relationships.

### Qualitative targets (national level) Skills and Abilities

For the social work degree, the student must

- demonstrate the skills and abilities required to develop and carry out social work at different levels of society in cooperation with the people concerned,
- demonstrate the ability to apply relevant statutes, in particular in the social field,
- demonstrate the ability to understand, investigate and analyze social processes and problems, and
- demonstrate the ability to identify, structure, investigate and evaluate efforts at individual, group and societal level.

## Qualitative targets (national level) Evaluation ability and approach

For the social work degree, the student must

- show self-awareness and empathic ability,
- demonstrate the ability to take a bolistic view of human action on the basis of relevant scientific, social
  and ethical aspects, with particular regard to human rights;
- demonstrate the ability for a professional approach and approach, demonstrate insight into the importance of teamwork and collaboration with other professions, and
- show the ability to identify their need for additional knowledge and to continuously develop their skills.
- Independent work (degree project). For the social work degree, the student must, within the framework
  of the course requirements, have completed an independent project (degree project) of at least 15
  higher education credits.
- For the social work degree, the specified requirements shall also apply, which each university itself decides within the framework of the requirements in this degree description.

#### Assessment matrix

How should the assessment be made if the applicant does not have any documentation?

- The time aspect
- Assessment on site or remotely / internet based
- Which area of questions
- Requirement level
- Clarify the validator's scope for interpretation

# The applicant

- Must be enrolled at a university
- Complete a form where they descibe their prior learning
- Attach all documentation and /or a personal letter

Validation criteria	Description	The applicant describe his/her prior learning
XXVIII Reflect on your own approach & your own professional role	Demonstrate the ability to reflect on one's own approach by raising awareness of one's own starting points as well as the profession's own assumptions that affect professional practice as a BSc in Social Work on several levels. Demonstrate the ability to reflect on one's own professional role in relation to users' own needs for support.	
XXIX Reflect on your own empathic ability	Demonstrate the ability to reflect on oneself, become aware of one's own role and the communicative interaction. In addition, show the ability to empathize by reflecting on others' experiences and being able to change perspectives and interpretations as well as distinguish between one's own and the user's experiences and feelings.

- Administrators
- The department's assessment group
- Decision by the Board of the Department
