## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Upper Secondary Diploma.

The foreign qualification gives access to higher education in Sweden. Additional general and specific entry requirements may apply.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

<b>Duration</b>	<p>3 years</p> <p>The qualification is based on 9 years of schooling.</p>
<b>Information about the qualification</b>	<p>The qualification was introduced year 2017. Previously the examination was known as Certificate of (Complete) Secondary General Education (Atestat mijnakarg (Iriv) yndhanur krtutyany).</p> <p>The qualification prepares for higher education study.</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Armenian National Qualifications Framework</a></p> <p>The national qualifications framework (The Armenian NQF) has 8 levels, where 1 is the lowest and 8 is the highest.</p>
<b>NQF level</b>	4
<b>Country information</b>	<p>Armenia is a full member of the Bologna Process, but has not yet completed the process of the European higher education area (QF-EHEA).</p>
