### About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Degree of Bachelor.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Специалист (**Specialist degree**)

<b>Duration</b>	3 years
<b>Credits</b>	The extent of studies is usually calculated as the number of hours.
<b>Information about the qualification</b>	<p>The degree was introduced in 1995. The qualification was replaced by "profesionalen bakalavar" in 2007.</p> <p>The qualification may include a degree project and a placement. The qualification gives access to Master's level programmes in Bulgaria.</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Bulgarian Qualifications Framework (BQF)</a></p> <p>The national qualifications framework (BQF) has 9 levels, where 0 is the lowest and 8 is the highest.</p>
<b>NQF level</b>	The degree was completed before the country had a NQF with 9 levels and therefore was not assigned a level.
<b>Bologna level</b>	1
<b>Recognised higher education institutions</b>	<p><a href="#">Register of Higher Education Institutions</a></p> <p>Please note the country can have additional recognised education institutions.</p>

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.



Not all qualifications are included in the figure.

\*Please note that the Advanced Higher Vocational Education Diploma is included in EQF och SeQF level 6, but not in Bologna level 1.
