## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Higher Education Diploma.

The foreign qualification belongs to the country's applied science sector.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks. Decisions on assigned levels in national qualifications frameworks (NQF) are made by the country in which the qualification is awarded. Our assessment does not mean that we have assigned a Swedish level for the foreign qualification.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Stručni pristupnik/Stručna pristupnica

<b>Duration</b>	2 years  The length of the study programme may also be 2,5 years.
<b>ECTS</b>	120 - 150 credits  In some cases, the transcript shows more ECTS credits than required for a degree.
<b>Information about the qualification</b>	The qualification is professionally oriented and belongs to Croatia's applied science sector. Parts of the qualification may be credited into a qualification that leads to the qualification "Strucni prvostupnik/Strucna prvostupnica" in Croatia.
<b>National Qualifications Framework (NQF)</b>	<a href="#">Croatian Qualifications Framework (CROQF)</a>  The national qualifications framework (CROQF) ) has 10 levels, where 1 is the lowest and 8.2 is the highest.
<b>NQF level</b>	5 (CROQF)
<b>EQF level</b>	5
<b>Bologna level</b>	short cycle
