Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Degree of Master.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Magistr (Degree of Master)

<b>Duration</b>	<p>1 - 3 years</p> <p>There are also combined vocational education and training degrees in some professions [doctor of medicine, dentist, veterinary] that requires 4-6 years of study.</p>
<b>ECTS</b>	<p>60 - 180 credits</p> <p>Combined study programmes comprise 240-360 ECTS.</p>
<b>Information about the qualification</b>	<p>The qualification includes a degree project. The qualification gives access to doctoral-level programmes in the Czech Republic.</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">For more information see National Referencing Report of the Czech Republic (EQF)</a></p> <p><a href="#">Framework of Higher Education Qualifications of the Czech Republic</a></p> <p>The Framework of Higher Education Qualifications of the Czech Republic is the qualification framework for higher education and has 3 levels, where I is the lowest and III is the highest.</p>

<b>Country information</b>	<p>The Czech Republic has referenced its existing qualifications system (in fact the education system) to the EQF. Qualifications included in the register of the National Qualifications System (NSK) are also linked to the EQF but the NSK is not a NQF as such.</p>

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.



Not all qualifications are included in the figure.

\*Please note that the Advanced Higher Vocational Education Diploma is included in EQF och SeQF level 6, but not in Bologna level 1.
