

Foreign qualification assessment

The extract indicates what a foreign qualification is comparable to in the Swedish qualification system. The information can be used when applying for a job or planning for further studies. Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Upper Secondary Diploma. The qualification is vocationally oriented.

The foreign qualification gives access to higher education in Sweden. Additional general and specific entry requirements may apply.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

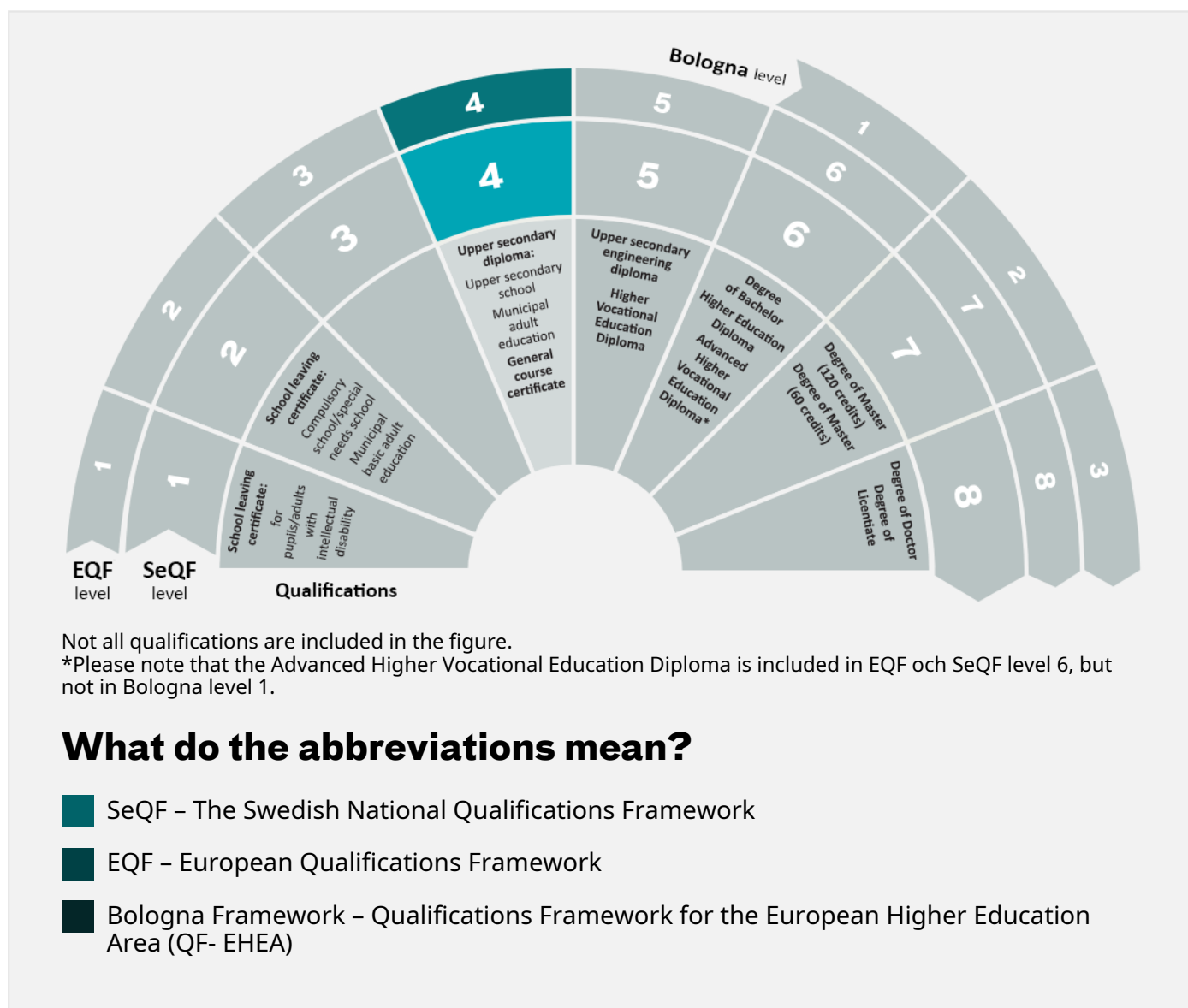

Facts about BTEC National Diploma

Duration	2 years The qualification is based on 11 years of schooling.
Information about the qualification	The qualification was awarded until 2019 and was replaced by the BTEC Level 3 Extended Diploma (QCF). The qualification is vocationally oriented and has different specialisations. It also gives access to higher education study.
National Qualifications Framework (NQF)	Regulated Qualifications Framework for England and Northern Ireland (RQF) Scottish Credit and Qualifications Framework (SCQF) Credit and Qualifications Framework for Wales (CQFW) The national qualifications framework for England, Northern Ireland and Wales (RQF och CQFW) has 8 levels, where 1 is the lowest and 8 is the highest. The national qualifications framework for Scotland (SCQF) has 12 levels, where 1 is the lowest and 12 is the highest.
NQF level	3 (RQF/CQFW)
EQF level	4
Country information	The United Kingdom consists of four parts, Scotland has its own education system and qualification framework that is separate from the one set for England, Wales and Northern Ireland.

The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.
